What's ID2025?

Congress-ku waxay ansixiyeen Xeerka REAL ID sanadkii 2005 si ay gacan uga geystaan la dagaalanka argagixisada iyo xatooyada aqoonsiga. Sharciga ayaa dejiyay shuruudo aqoonsi oo cusub oo loogu talagalay safarka hawada ee gudaha iyo in la galo qaar ka mid ah xarumaha fadaraalka. Si loogu hoggaansamo, gobolladu waa inay abuuraan aqoonsi sugan, oo aan lagu been abuuran karin oo u baahan codsadyaashu inay keenaan caddaynta aqoonsiga iyo deganaanshaha Maraykanka ee sharciga ah. Dhammaan goboladu waa inay u hogaansamaan sharciga kahor inta aanu dhaqangalin bisha May 7, 2025.

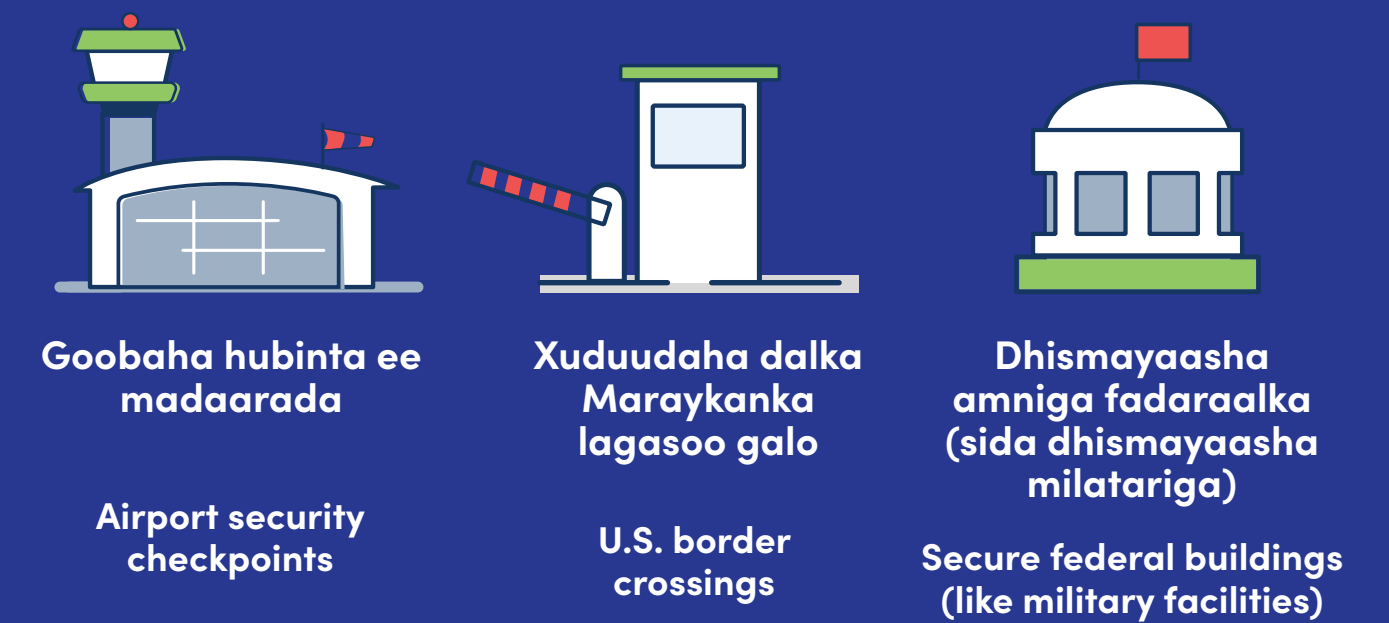
Congress passed the REAL ID Act in 2005 to help combat terrorism and identity theft. The law set new identification requirements for domestic air travel and to enter some federal facilities. To comply, states must create a secure, counterfeit-resistant ID that requires applicants to provide proof of identity and legal U.S. residency. All states must comply with the law before it takes effect on May 7, 2025.

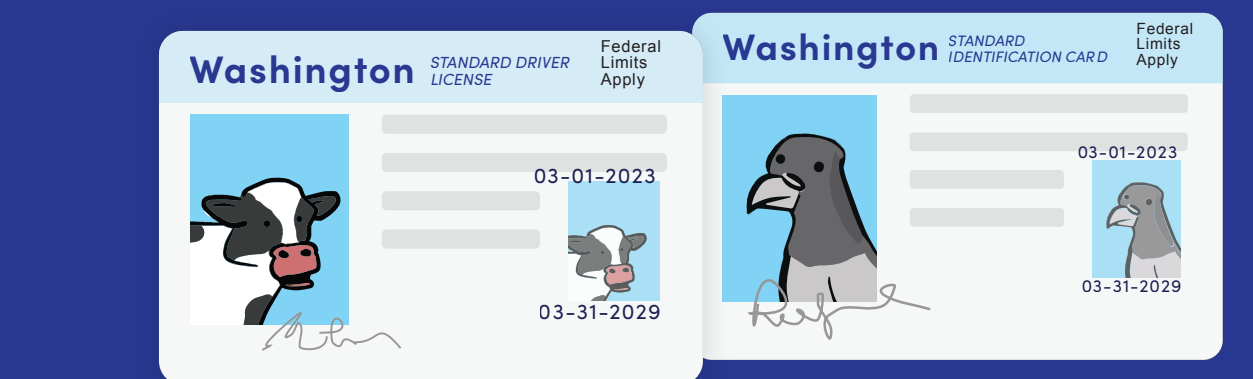
REAL ID waxay saameyn doontaa gelitaanka meelaha ay maamusho dowladda fadaraalku.

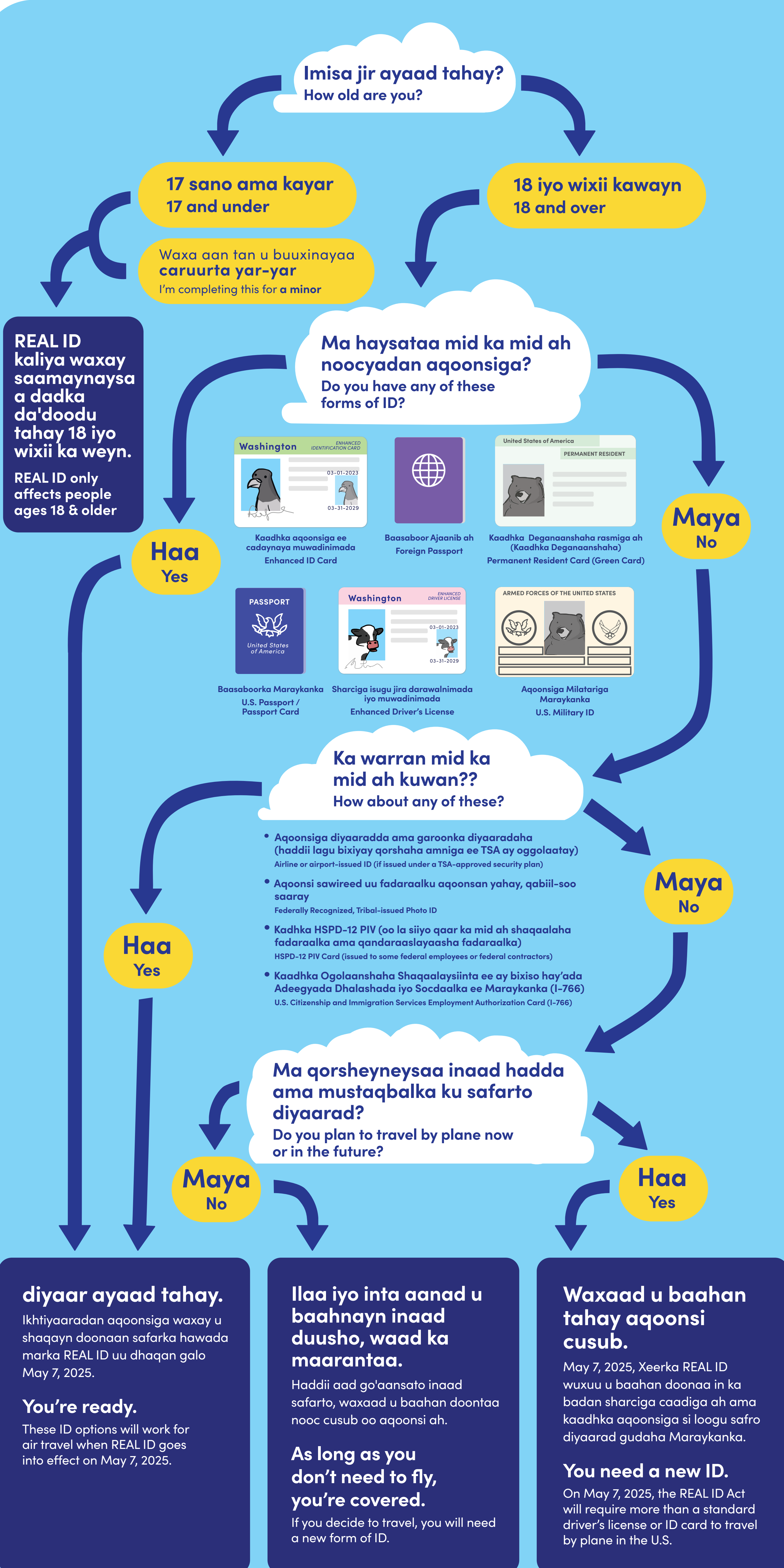
Can I still use a standard driver's license or ID card?



Haa. REAL ID kaliya waxay saamaynaysaa dadka ku safraya diyaarad ama gelaya xarumaha fadaraalka qaarkood. Waxaad sii wadan kartaa inaad isticmaasho sharciga darawalnimada caadiga ah si aad u wado, ama aad u isticmaasho aqoonsiga caadiga ah si aad ugu safarto tareen ama doomaha gobolka, codbixinta, iyo helitaanka adeegyada caafimaadka.

Yes. REAL ID only affects people who travel by plane or access certain federal facilities. You can continue to use your standard driver's license to drive, or use your standard ID to travel by train or state ferry, vote, and access health services.

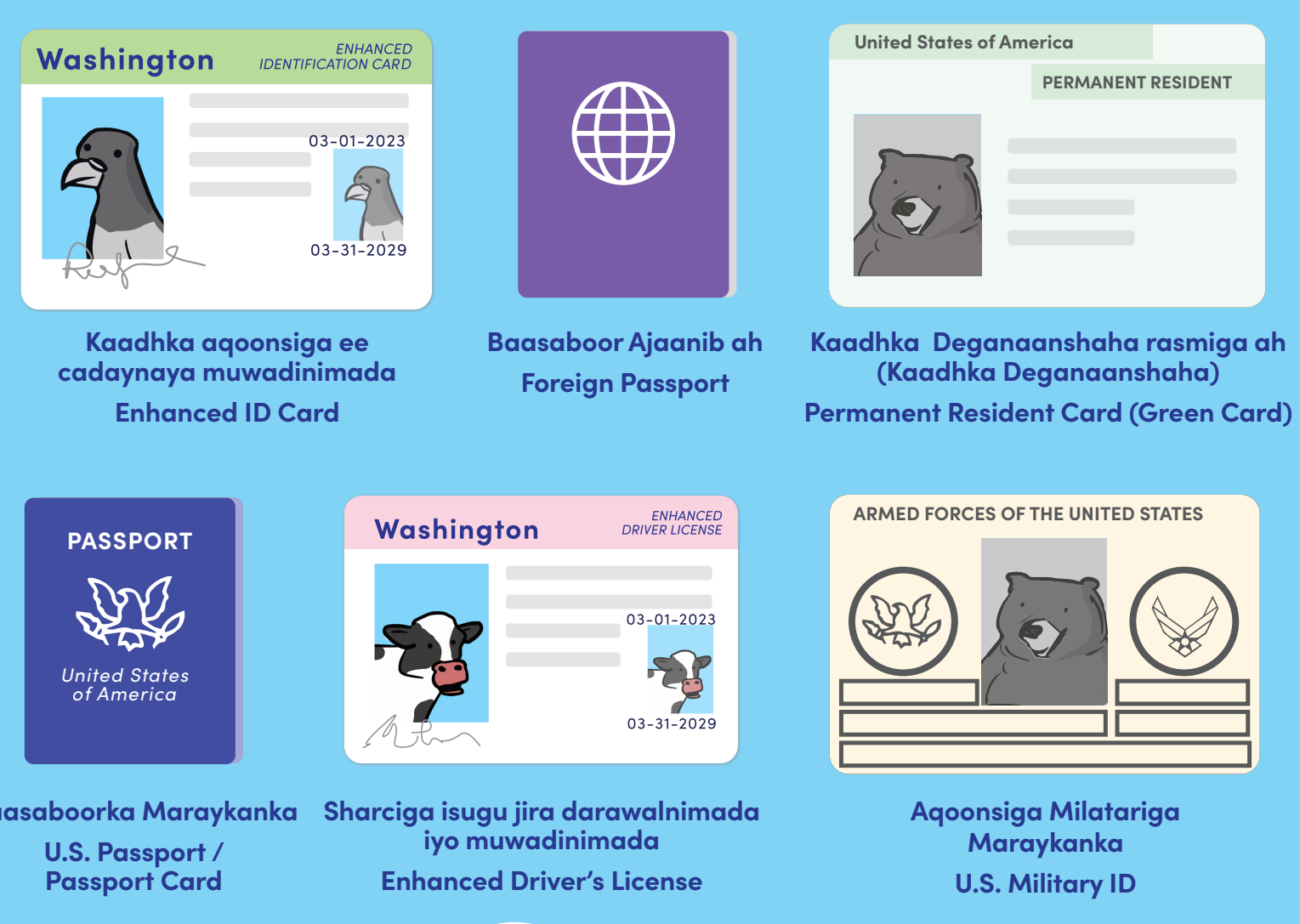

- Aqoonsiga diyaaradda ama garoonka diyaaradaha (haddii lagu bixiyay qorshaha amniga ee TSA ay oggolaatay)

- Aqoonsi sawireed uu fadaraalku aqoonsan yahay, qabiil-soo saaray
Federally Recognized, Tribal-issued Photo ID
- Kadhka HSPD-12 PIV (oo la siiyo qaar ka mid ah shaqaalaha fadaraalka ama qandaraaslayaasha fadaraalka)
HSPD-12 PIV Card (issued to some federal employees or federal contractors)
- Kaadhka Ogolaanshaha Shaqaalaysiinta ee ay bixiso hay'ada Adeegyada Dhalashada iyo Socdaalka ee Maraykanka (I-766)
U.S. Citizenship and Immigration Services Employment Authorization Card (I-766)
